1. Name, Headquarters, and Purpose

The name of the organization is “Next Level Church”.

The seat of Next Level Church is located at New Orleans, Louisiana, USA.

The purpose of Next Level Church is to guide its members toward financial freedom and the highest possible social standing.

This is achieved through support in personal, spiritual, and professional development, as well as through education, community projects, spiritual guidance, ethical entrepreneurship, and self-determination over body and mind.

2. Core Beliefs

- Every individual possesses unique and inherent value.
- No deities are worshipped; the focus is on personal potential and self-development.
- The foundation of our belief is the pursuit of personal perfection, which is intrinsically linked to financial freedom.
- Financial freedom is seen as a key to a fulfilled life, as it enables individuals to help themselves and others.
- Next Level Church considers the intellectual and spiritual development of its members essential. The goal is to help each person cultivate awareness, clarity, and inner strength, free from external control, dogmas, or dependency.

3. Membership

Any person who shares the core beliefs and is willing to actively participate in the community may become a member of Next Level Church.

Membership is voluntary and can be terminated at any time.

Every member commits to respecting the values of Next Level Church and actively contributing to the achievement of its shared goals.

4. Governance Bodies

Community Council:

The Community Council consists of elected representatives and is responsible for the strategic direction and oversight of the organization's activities.

Membership Assembly:

Members meet regularly to make key decisions collectively and discuss the development of Next Level Church.

Leadership Team:

The Leadership Team is responsible for implementing decisions and organizing events and training programs.

Church Offices:

Church offices are appointed for life and can only be revoked if the officeholder violates community rules, endangers the lives or health of others, or harms the community through their actions.

5. Finanzierung

Next Level Church is funded through voluntary member contributions, donations, and revenue from community projects. All financial resources are used exclusively for the purposes of Next Level Church.

6. Werte und Ethik

Respect, transparency, and mutual support are core values of Next Level Church. Every member commits to acting honestly, respectfully, and responsibly.

Next Level Church rejects all forms of discrimination or exclusion.

The complete self-determination over one's body and mind is recognized as a sacred fundamental right.

Education, enlightenment, and the right to self-determination are inalienable values of our community. We reject any form of ownership or control over others, as this contradicts self-determination.

At the same time, we emphasize that self-determination has its limits where vulnerable individuals, particularly children, are at risk.

We unequivocally reject any form of sexual activity with children, regardless of context or justification. Despite our commitment to sexual education and individual freedom, the protection of children is an unwavering principle of our church.

7. Appointment of Offices and Expulsion

All church offices within Next Level Church are appointed for life and are inheritable. A member may be expelled from the church if they violate community guidelines, endanger others, or compromise the integrity of the community. Such expulsion is permanent.

If an expelled member holds shares in a church pool, these will be repurchased at the original issue price and returned to the community.

8. Church Pools

Church pools are established to fund selected projects deemed essential to the shared mission of Next Level Church.

They are independent of the MNLO structure and not tied to downlines or their participation. Pool shares are indivisible, inheritable, but non-transferable.

Shares can only be returned to the church at the original issue price and only after the contractually agreed lock-in period has expired.

The acquisition of pool shares is exclusively reserved for church members who also hold an active MNLO membership. This also applies to any payouts.

All church projects are exclusively for members. Our philosophy is clear: “All in or go home” – be fully committed, or not at all.

9. Amendments

These bylaws may be amended by a simple majority vote at the Membership Assembly.

10. Dissolution of the Organization

The dissolution of Next Level Church can only be decided by a three-quarters majority of its members. In the event of dissolution, any remaining funds will be used for charitable purposes aligned with the goals of Next Level Church.

11. Effective Date

These bylaws may be amended by a simple majority vote at the Membership Assembly.
